

IHSAA Web Site Terms and Conditions of Use

1. **Terms.** By accessing this and any web site of the Indiana High School Athletic Association, Inc.'s (IHSAA), you are agreeing to be bound by these Terms and Conditions of Use, all applicable laws and regulations, and agree that you are responsible for compliance with any applicable local laws.
